INDUSTRY NEWS

California recycling

January 17 – (https://carpetrecovery.org/newsblog/blog/) CARE has revised their Five-Year Plan and submitted it to CalRecycle for approval. The new plan calls for an update to the Differential assessment. If approved by CalRecycle this change will go into effect April 1, 2023. Current charge is in parenthesis.

- Broadloom carpet with less than 10% post-consumer recycled content (PCR) (\$0.35): \$0.58
- Broadloom carpet with at least 10% PCR (\$0.33): \$0.56
- Carpet tile with less than 10% PCR (\$0.50): \$0.73
- Carpet tile with at least 10% PCR (\$0.48): \$0.71

The New York governor signed a Carpet Stewardship Law which will start in January 2026. No details are available but fcB2B will continue to follow this to determine if changes to the standards are needed.

VERSION 3.2

Moving to version 3.2 and certifying documents is still a priority to ensure your customers are receiving quality data that allows them to Search, Find and Sell your products. There is a software provider that is close to starting certification and a distributor that is getting close to starting as well.

VALIDATION FOR 2.X DOCUMENTS

The tool we are using for validating the v3 documents during certification has now been configured to validate the v2 documents as well. If you are having problems or complaints about a document let Lewis know. It's a quick process to validate and provide the results. Currently there isn't a fee for this service.

NEW PROGRAM LEVEL

There has been a new program level created for companies that are interested in just providing a spreadsheet product catalog. The new level is on the join page and only provides access to the non-EDI format spreadsheet and no access to the website backend.
