There were several temporary committees created after the annual meeting. Below is the status of a few of these committees.

- 855 Order status The list of statuses has been reviewed and the committee came up with a list that are important for a retailer to know initially. The following note has been added to the 855 document under the ACK segment. The v3.2 Draft version is available on the fcB2B website MBR Toolbox > X12 Document Repository > 855 PO Acknowledgement.
 - The following Line-Item Status Codes (ACK01) have been identified as having a higher importance when multiple statuses apply to a single line. These should be returned on the initial 855 and any remaining on subsequent 855's.
 - IE Item Accepted, Price Pending
 - IP Item Accepted Price Changed
 - IR Item Rejected
 - R2 Item Rejected, Invalid Item Product Number
 - R3 Item Rejected, Invalid Unit of Issue
 - R4 Item Rejected, Contract Item not Available.
- The 850 Note committee has completed the review of the document, and several notes were found to have been copied over from the v2 document and did not apply. The notes have been updated or corrected.

UPDATES TO FCB2B.INFO WEBSITE

VALIDATION FOR 2.X DOCUMENTS

The tool we are using for confirming the v3 documents during certification has now been configured to validate the v2 documents as well. If you are having problems or complaints about a document, send us an email at ldavis@wfca.org. It's a quick process to validate and provide the results. There is not a fee for this service and can be helpful to resolve issues.
